

SUMMARY ANNUAL REPORT FOR MARVELL SEMICONDUCTOR MEDICAL PLAN

This is a summary of the annual report of the Marvell Semiconductor Medical Plan (Employer Identification Number 77-0398669, Plan Number 501) for the plan year 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Marvell Semiconductor, Inc. has committed itself to pay certain Medical, Dental, Vision and Flexible Spending Account claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with Lincoln National Life Insurance Company, LegalPlans, USA, Kaiser Foundation Health Plan Inc, LifeSecure Insurance Company, Delta Dental of California, Ace American Insurance Company, Genworth Life Insurance Company, Tufts Associated Health Maintenance Org., Inc., Vision Service Plan and Cigna Health and Life Insurance Company to pay certain Life insurance, AD&D, EAP, Legal, Health, Prescription drug, HMO contract, Long Term Care, Dental, Vision, Leave Services, Temporary disability, Long-term disability, Evacuation and I EAP claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$17,411,590.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2022, the premiums paid under such "experience-rated" contracts were \$0 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$338,853.
